This memorandum of understanding (MoU) is made and executed to establish the initial framework or cooperation between LNM INSTITUTE OF INFORMATION TECHNOLOGY, Jaipur, and HARCOURT BUTLER TECHNICAL UNIVERSITY, Kanpur is signed on May 28, 2024.

THE LNM INSTITUTE OF INFORMATION TECHNOLOGY having its campus at Gram Rupa ki Nangal, Post-Sumel, Via-Jamdoli, Jaipur-302031, Rajasthan, India (hereinafter referred as "LNMIIT" which expression, unless excluded by or repugnant to the subject or context, shall include its successors-in-office, administrators, and assigns) herein after to be referred as First Party.

and

HARCOURT BUTLER TECHNICAL UNIVERSITY, having its campus at Nawabganj, Kanpur-208002, Uttar Pradesh, India (hereinafter referred as "HBTU" which expression, unless excluded by or repugnant to the subject or context, shall include its successors-in-office, administrators, and assigns) herein after to be referred as Second Party.

Preamble

1. The Parties wish to establish a cooperative relationship with the aim of developing and fostering, primarily but not limited to, academic and scientific research linkages between the two institutions.
2. This Memorandum of Understanding (MoU) sets out the framework for the cooperative relationship between the Parties.

Provisions

1. Areas of Co-operation

Both the institutions will support each other's endeavours in academic programmes and research activities in the following areas:

- a) Partnering and supporting each other through joint research initiatives through participation in nationally and internationally funded projects, sharing of research facilities and resources, and joint publication of research findings.
- b) Organization of joint academic and scientific activities, such as lectures, conferences, seminars, workshops, symposia, and training programs.
- c) Student exchange program to promote academic exchanges between students, including academic programs, outreach activities, internships, and research opportunities.
- d) Faculty and Staff exchange program to promote academic and cultural exchanges between their faculty and staff, including joint research projects, guest lectures, and participation in academic conferences.
- e) Exchange of scientific, technical, and academic information.
- f) Joint supervision of postgraduate and PhD students.
- g) Universities may collaborate to transfer technology and knowledge from the laboratory to the market, promoting innovation, entrepreneurship and supporting economic growth.
- h) Any other collaborative efforts the Parties consider being appropriate from time to time.

2. Activities and Projects

Each collaborative activity or project to be initiated under this MoU will be subjected to a Supplementary Agreement between the Parties. Such Agreements will set out the Party's obligations, responsibilities and the conditions relating to each activity or project and compliance with applicable laws, rules, regulations, and procedures of the host institution.

3. Capacity building

Universities may collaborate to build institutional capacity, providing training and support to faculty and staff, as well as sharing best practices in areas such as academic governance, curriculum development, and assessment.

4. Funding

Each Party shall bear its own costs and expenses for the activities arising from this MoU unless otherwise mutually arranged and agreed upon.

Neither party shall enter a contract on behalf of the other Party nor commit any expenses without the prior approval of that party in writing.

5. MOU Management and Oversight

The universities agree to establish a nodal officer/MOU coordinator to oversee the implementation of the collaboration areas identified in this MOU. The nodal officer/MOU coordinator of both universities will meet periodically to review progress, identify areas for improvement, and discuss future collaboration.

6. Legal Effect of this MoU

This MoU outlines the framework of a working relationship between the Parties. Except as expressly mentioned, it is not intended to constitute a contract, but is built on goodwill and is binding in honour only. No partnership or joint venture is created by this MoU, and neither Party can commit the other financially or otherwise to third Parties.

7. Policies and Procedures

Faculty/Staff/students of either institution involved in any activity under this MoU shall abide by the applicable rules, regulations, and procedures of the host institution.

8. Confidentiality

Each Party shall keep all information or material acquired or produced in connection with this MoU confidential and will not without prior written consent of the other Party use or disclose or otherwise make available this information or material in any form to any person, except as required by the law. This provision is binding on the Parties and will survive the termination or expiry of this MoU.

9. Intellectual Property

Ownership of Intellectual Property shared by the Parties pursuant to this MoU will remain with the contributor or creator. All such materials must be treated as confidential and not for public circulation unless specifically agreed otherwise by both Parties in

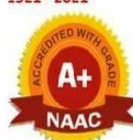

10. Use of Name and Logo

A Party will not use the name or logo or any variation of the name or logo of the other Party, or of any member of the other Party, or its employees or students, in any publicity, advertising or news release without the prior written approval of an authorised representative of that Party. This provision is binding on the Parties and will survive the termination or expiry of this MoU.

11. Standards of Performance

The Parties agree that all obligations under this MoU and any Agreement resulting from this MoU will be performed in a manner protective of and consistent with both Party's reputation for excellence and integrity in education, research, and scholarship.

12. Dispute Settlement

The parties agree that this instrument is produced in good faith, so that any dispute arising from its interpretation, implementation or execution will be resolved through written mutual agreement between the parties. In the case of any dispute, the jurisdiction of the resolution shall be the Court of law, Kanpur Nagar U.P.

13. Termination

In so far as they do not interfere with any activities in progress, amendments to this MoU and agreements following this MoU may be made at any time, provided they are in writing and reflect the joint wish of both Parties to this Agreement.

In so far as the termination does not interfere with any activities in progress, either Party may terminate this agreement by giving **three (3)** months written notice. The termination of this MoU will not affect any activity or project that is the subject of a further agreement between the Parties unless the relevant agreement provides otherwise.

14. Effective Date and Duration of MoU

This MoU takes effect on the date the last Party signs and will continue for a period of **3 years** only. The Parties may agree in writing to extend it for a further period to be determined.

15. Applicable Laws / Governing Laws

This Agreement shall be interpreted in accordance with the laws of the Government of India.

16. Link Coordinators
